In NSW, your privacy is protected by the **Privacy and Personal Information Protection Act 1998 (PPIP Act)** which outlines how NSW public sector agencies, including government agencies, local councils and universities, manage and protect personal information, and the **Health Records Information Privacy Act 2002 (HRIP Act)** which promotes fair and responsible handling of health information. The HRIP Act applies to an organisation in NSW that is a health service provider or that collects, holds or uses health information. This includes both public and private sector organisations.

This Privacy Awareness Week, follow these tips to protect your privacy and review your privacy settings:

- Store documents such as passports, driving licences, pay slips, tax returns, bank statements and bills in a safe place.
- Shred or destroy personal documents you are throwing away such as bills, receipts, credit card statements and other documents that show your name, address or other personal details.
- If you need to post personal documents, ask the post office for advice on the most secure method. Limit the number of documents you carry around on you. Don't leave personal documents in your vehicle or unattended.
- Check your bank and credit card statements for unusual transactions. Always use a different password and PIN for different accounts and take care when using public computers to access personal information.
- Regularly check your records. Make sure your information is correct and up to date.
- Delete unused apps from your phone, and disable location, camera and microphone access where it's not required.

All NSW citizens have a right to have their personal information protected. If you are concerned about a breach of your privacy, you can request with us to conduct an internal privacy review.

The Information and Privacy Commission (IPC) can also help you understand privacy laws in NSW and give you information on how to protect your personal information and assert your rights.




