#### COBB & CO HERITAGE WEEKEND

Council resolved at the February 2024 Ordinary meeting to hire 2 Cobb & Co coaches from Drayhorse Shires at Boonah for the weekend of the 3rd and 4<sup>th</sup> August in the lead up to the 100 year anniversary of the last official Cobb & Co coach run in Australia (between Yuleba and Surat QLD) co-ordinating with subsequent events in Toowoomba, Yuleba and Surat. Council resolved to allocate the required funds in the 2024/25 budget and meantime seek grant funds and ticket sales to help offset these costs. Council plans to create a Cobb & Co Heritage Drive and associated signage to complement shire tourism and historic values.



A very successful weekend was had starting on the Saturday at the Tenterfield Railway Museum, which was fitting given that Cobb & Co built the railway line from Glen Innes to Tenterfield, and coincided with the monthly markets attracting a strong crowd for both the markets and coaches.



At the Official Opening Mayor Bronwyn Petrie spoke on the background for the event and introduced guest speakers John Osborne & Cobb & Co author Hazel Johnson, with Councillor Peter Petty reciting a poem he wrote especially for the occasion. Local Member Janelle Saffin was a late apology due to unforseen circumstances. Local vintage, veteran and classic cars were also on display to the delight of the crowd. The coaches operated until 12 noon with booked patrons as well as walk up attendees keen to take the opportunity for a ride on a coach. While the horses had a break the Tenterfield Autumn Festival committee held a Soup & Damper lunch at the Tenterfield Station Homestead courtesy of Beryl and John Dean, with music supplied by Mr Nick Wolverson.



From 2.00-4.00pm the coaches operated from Shirley Park. There was a great moment when local Lisa Tolley brought her 1924 Willys Overlander vintage car along to be photographed with the coaches given the significance of the date.



The Sir Henry Parkes School of Arts Museum, Centenary Cottage Museum, Spanish Flu Isolation Ward Museum and Tenterfield Saddler were open for visitors as well as Arrajay Downs small animal farm.

On Sunday the event moved to Liston and was supported by the Warwick Car Club and Mr John Hinitt from the Tenterfield Car Club, providing a good display of cars. Mayor Bronwyn had an early frosty start to erect banners and signs cautioning drivers of the coaches and indicating the car display. The Liston Hall committee provided a delicious morning tea, sausage sizzle and afternoon tea, and the hall heritage display. A large crowd gathered at the Cobb & Co & Collectables Museum and were entertained by guest speakers John Osborne and Hazel Johnson.



Hazel's father Mr John Burton constructed the replica coach and wagon housed in the museum. During the break a Soup & Damper lunch was held at nearby Aloomba Lavender Farm. As well as the locals and people from Stanthorpe travellers also stopped to go for a ride. Willsons Downfall historic cemetery was also promoted.

Costume prizes were awarded to Kay Hurtz, Georgina & David, Cheryl Jacques each receiving a family pass to the Toowoomba Cobb & Co Museum, the donation of which was arranged by Mr John Osborne.



A special mention of the sponsors Horseland, Janelle Saffin, Tenterfield Autumn Festival, Peter Petty Rural Transport and Bronwyn Petrie, as well as the caterers Kim Rhodes, the Bonner family, the Liston Hall Committee and all the helpers for making the weekend a success.
